Nature / Type of Organisation and Services Provided:

Tawhid is a non selective Independent Secondary school for boys aged 11-16. It is located in the London Borough of Hackney. We at Tawhid believe each child is a Gem. Through the combined efforts of the School, Pupil & Parents, we aim to provide a high standard of education in a safe & secure environment where all can thrive and achieve to their full potential

Our commitment to safeguarding children:

The School is committed to providing a safe, caring and welcoming environment where every child is able to reach their full potential free from harm, abuse and discrimination.

All staff and volunteers are expected to discharge their safeguarding responsibilities effectively and recognise that high self-esteem, confidence, peer support and clear lines of communication with trusted adults helps all children, especially those at risk of or suffering abuse, to thrive.

The School will work closely with all agencies to ensure there are adequate arrangements within the school to identify and support pupils at risk of harm.

The Governing Body will ensure there will be a trained Lead Governor, Designated Safeguarding Lead (DSL) and Deputy safeguarding leads (DDSL)

Risk that opportunities to identify early the signs of abuse, neglect or other concerns might be missed.

How are we mitigating this risk? (1)

Senior Leadership prioritises safeguarding and promoting the welfare of children at every opportunity to ensure that the child protection policy and procedures are implemented and followed

All adults in the school are required to be up to date with Part 1 KCSIE with regular training by CHSCP. All new staff to undertake safeguarding Induction training

Social Media / Online or any type of cyber - bullying

How are we mitigating this risk? (2)

Staff keep up with the latest trends, educating pupils through the curriculum, using a range of mediums and safeguarding mechanisms: Code of Conduct for remote learning / ICT & eSafety Rules / Workshop external agencies / PSHE / Assemblies / Themed week / Extended Tutor Period / E-safety and Safeguarding Policies / training / filtering & monitoring.

Risk that children might face (4)

Mental Health
Students in exam years experience high levels of anxieties to perform to high expectations

How are we mitigating this risk? (4)

Systems in place to identify & use a range of mediums to support pupils to manage their anxieties, promote positive health, well-being & resilience among students through;
Enrichment / PSHE guide learning / Careers / Additional subject support
Planning & developing revision and exam techniques
Emotional coaching / Managing expectations with parents/carers

Risk that children might face (5)

Student will not seek help when needed and remain "Silent"

How are we mitigating this risk? (5)

Ensure student build confidence to speak out with a trusted member of staff they can relate to (Tutor)
Use themed assemblies and tutorials to develop confidence
PSHE tackles full on all types of bullying / behaviours and steps to take
Helpful external contacts, links and guidance published in Pupil planners and school website
Display names of DSL & DDSL
